6-A.2 Motion by Trustee Roberts and seconded by Trustee Kemper to approve and renew Village President and Local Liquor Commissioner Emergency Order No. 2 providing for liquor licensees holding any liquor license which provides for on premise consumption of alcoholic liquor or beer and/or wine shall be permitted to

serve their respective licensed beverages for off-premise consumption in conjunction with receipt of a permit, compliance with the permit, at the location specified in the permit, and adherence to the guidelines as provided in and authorized by the Outdoor Dining-Recovery Phase of Covid-19 Pandemic Guidelines issued as an administrative order by the Village of Hanover Park, dated June 1, 2020, or as revised thereafter. No off-premise consumption or serving pursuant to the Order or this motion shall occur before 7:00 a.m., or after 10:00 p.m. of any day except Friday and Saturday night for which the closing hour shall be 11:00 p.m. This motion shall be in effect until the end of the day, July 16, 2020 from the day of its passage, and shall continue for 60 days thereafter unless repealed or amended by the Village Board.

Village Clerk Corral Sepúlveda spoke the state of our country, the lack of public trust, the civil unrest, the Coronavirus outbreak, racism, inequities in our communities, and shared a heartfelt expression of personal thought and experiences.

9. CORPORATION COUNSEL'S REPORT – BERNARD Z. PAUL

Attorney Paul bid farewell to former Trustee Fanny López Benítez and welcomed Liza Gutiérrez who will fill the recently vacated Trustee seat.

10. VILLAGE TRUSTEES REPORTS

10-A. HERB PORTER

Trustee Porter thanked former Trustee López Benítez for her service to our community and welcomed newly appointed Liza Gutiérrez to the Board.

Trustee Porter reenacted the last 8 minutes and 46 seconds lived by George Floyd, an unarmed man, as he was murdered in plain sight, by Minnesota Police Officer Derek Chauvin.

Trustee Porter invited all to the first of a series of e-Townhalls entitled "Peace Together Our Community" to reflect, reconcile, restore, and renew our commitment to a just society. The first Peace Together Our Community e-townhall is scheduled for Wednesday, June 10, 2020 from 6:00 p.m. to 7:00 p.m. The event is a concerted effort of Trustee Porter and Trustee Shahjahan. The event will host the DuPage NAACP President Michael Childress, Cook County Commissioner Kevin Morrison, Hanover Park Police Chief Mike Menough and DuPage County Sheriff Jim Mendrick as panelists.

10-B. SHARMIN SHAHJAHAN

Trustee Shahjahan spoke to her solidarity with Trustee Porter and the Black Lives Matter movement, efforts to ensure that all residents and business owners feel safe in our community, the Cultural Inclusion and Diversity Committee efforts, community engagement, fair practices, policies and Covid-19 safety measures.

10-C. BOB PRIGGE

Thanked Trustee Porter and Trustee Shahjahan for coordinating the e-Townhall event and noted that he looks forward to participating in the event.

10-D. RICK ROBERTS

Trustee Roberts spoke to including but not limited to; US history as it applied to the integration of Black and Latino servicemen in the military, shared personal beliefs, the injustice surrounding George Floyd, his

conviction in religion and the need for equal justice for all.

10-E. JAMES KEMPER

Trustee Kemper spoke to his agreement with the statements made by Village Clerk Corral Sepúlveda and Trustee Porter, noted that his experience in the military was one of brotherhood with all soldiers Black or White. He also spoke to his first experience with racism in Hanover Park in the 80's.
