Code Enforcement Reminder...

**A REMINDER TO KEEP YOUR GRASS MOWED
 LESS THAN 8 INCHES IN HEIGHT!**

The Code Enforcement Unit would like to remind residents that Village Ordinance 18-91-302.4 makes it unlawful for a property owner to allow any weed, grass or plant (except ornamental trees, bushes or flowers) to exceed eight inches in height. Neighborhoods remain pleasant places to live and property values are protected when property maintenance ordinances are followed. Curb Appeal Program

Each year, the Hanover Park Code Enforcement Unit inspects all residential properties as part of its Curb Appeal Program. When violations are found, the resident is notified with a door hanger tag and a follow-up letter via U.S. mail. Often, residents are already planning on making the needed repairs in the coming months. If a resident needs more time than allotted in the initial notification, we recommend they contact the Code Enforcement Officer (CEO) listed on the notice for an extension. The key is maintaining communication with the CEO and making a good faith effort to achieve compliance with the regulations.

The goal of the Curb Appeal Program is to work with the residents of the Village to gain compliance. The CEO's and Appearance Officer will work with residents to get the property maintenance issues resolved so that the property looks good and the owner is not summoned to housing court.



Below are some common items requiring correction:

- Tall grass and weeds (over 8 inches in height), a ticket will be issued to the homeowner if the Village is required to initiate grass cutting after a 7 day violation notice;
- Garbage and recycling containers illegally stored in front of the home or at the side of the home in public view. Store the containers behind the Home with tight-fitting lids or keep them inside your garage;
- House address numbers not displayed on the front of the house (numerals not less than 4 inches high);
- Driveways in serious disrepair;
- Missing or torn window screens;
- Rotting wood or peeling paint on the exterior;
- Gutters and downspouts not in good repair;
- Inoperable vehicles (including vehicles not displaying current license plates) may not be stored except in a garage or, no more than one vehicle under a commercially manufactured cover in good condition;
- No bare areas or ruts in grass caused by pedestrians or vehicles;
- Holiday decorations must be removed within 90 days of the Holiday.

Fire Department



Fire Department Receives New Vehicle

The fire department has taken delivery of a new custom designed fire ground incident rehabilitation vehicle. The vehicle is used to provide support in the form of rest, rehydration, nourishment, core body temperature cooling and medical monitoring of firefighters who have been engaged in physically demanding tasks at the scene of the incident. Nationally, 50%-60% of firefighter line-of-duty death are due to cardiovascular issues. More than half of all injuries are cardiovascular or heat stress driven. This new unit, staffed by the department's volunteer Fire Corps Rehab Response Team, carries the necessary equipment to address these physiological challenges, which ultimately enhances firefighter safety.

In years past the department has provided this service using a repurposed ambulance. Although the old unit served the team well, it had multiple limitations based on design and size that have been corrected with this new custom unit.

The Fire Corps Rehab Response Team not only provides services to the Hanover Park Fire Department, but regularly assists our neighboring agencies on an as needed basis.

Transit Tax Benefit

Attention transit riders and business owners. If you take the train or ride the bus, here are some potential tax savings for you!

Recent congressional action increased the federal transit tax benefit. A transit rider can now claim up to \$255 per month free of Federal tax towards the purchase of transit service. This benefit, obtained through a participating employer, provides up to a 40% cost savings of commuting on transit for an employee. The tax credit increases from \$130 to \$255 which means that all Metra monthly ticket zone fares are either fully or substantially covered (only the five stations in zones K and M are not fully covered). Pace and CTA fares are fully covered. New products from the RTA make it easier for the commuter to participate and provide even more savings for employers who offer this incentive.

2016 Roadway Projects

Roadway improvement projects for 2016 include the **total reconstruction of Celebrity Circle**. The tentative schedule for construction of this road is set to begin in April. Patching and repair on other miscellaneous roads throughout the Village will also take place.

DuPage County will be working on the **S-Curve on County Farm Road** south of Ontarioville Road installing new lighting and an application of high friction asphalt in late spring or early summer as materials become available. This is part of an ongoing effort, along with the lowering of the speed limit, to reduce the number of traffic accidents associated with the S-Curve.



I-390 Project Update (Elgin O'Hare Western Access)

On July 5th, electronic tolls will begin to be collected on the first segment of I-390 from Lake Street to I-290. For the month of July, drivers with unpaid tolls will be given an extended grace period until 7/31/16, following which the 7-day grace period will resume. In 2016, the Illinois Tollway will continue construction of I-390 east to Illinois Route 83, including the construction of bridges and frontage roads to accommodate local traffic.

The second portion from I-290 to Illinois Route 83 will begin collecting tolls by the end of 2017. Passenger vehicles traveling the full length of I-390 will pay \$1.90 and all tolls will be collected electronically with an I-PASS.
